2. ELIGIBILITY: Restricted to Members and Affiliate Members of the Thames Motor Cycle Club and invited guests
3. CLASSES: Expert, Inter, Novice, Over 40, Over 50, Sportsman, Pre 67, Wobbler, Youth Expert, Youth Inter, Youth Novice, Youth Beginner
4. ENTRIES: To be completed and handed to the Secretary of the Meeting prior to the start
5. FEES: Adult = £12.00 Youth = £10 Day Membership = £ 2.00 ACU Trials Registration if not Registered = £10.00. Cheques to be made payable to THAMES MCC
6. AWARDS: Club Championship Points
7. COURSE: 4 laps of 10 Sections all on private land
8. CHILD PROTECTION: Point of Contact is as Secretary of the Meeting (NSC 6.14)
9. OBSERVING RULES: Riders must compete in groups and observe each other, riders found competing alone may be subject to disqualification by the Clerk of the Course (NSC 6.04)
