

### FINAL INSTRUCTIONS

COVID-19: The trial is being held under a Covid-19 permit as issued by the ACU. You have confirmed that you have read the Covid-19 Crisis Risk Assessment for this trial and agreed to be bound by this. You understand that despite the precautions taken by the club and other riders, you may be exposed to the Covid-19 virus. Please do not attend if you are unwell or suffering any symptoms, please let SoM know and you will receive a refund. Please provide your own first aid kit for minor injuries

**CAR PARKING:** Gates open at **9.00am, please provide your own riding numbers** (marked with the colour of the route you will be riding) and show to gatekeeper, then proceed to the parking area and stay at a safe distance from closest vehicle

**MACHINE EXAMINING:** It is your responsibility to ensure your machine is suitable and proper for the purpose.

**START ORDER:** If you are unable to ride, please contact the Secretary in advance as there is a reserve list of riders. We will start riders in groups of six. If you wish to ride with friends then please organise yourselves into a group of 6, otherwise the starter will do so. It is your responsibility to ensure that you maintain social distancing and please be patient. No more than 6 riders to be present at any section, if you arrive to find more, please wait at a suitable distance. A one-way system will operate through the section for inspection purposes – again no more than 6 riders at a time. The furthest clean tie breaker will not be used.

**COURSE:** 3 Laps of 12 Sections with 3 routes. No Road Work

**CATERING:** Naughty but Nice will be on site for your refreshments, please make use of their facilities

**LITTER:** Please take all your litter home with you. Staged in accordance with the ACU Environmental Code.
